## County MADD aids those who grieve

In the midst of the holiday spirit, candles burn for those who have died in alcohol-related traffic accidents.

More than 100 people gathered Monday at Nordin Park United Methodist Church in Farmington Hills for the eighth annual candlelight vigil sponsored by Mothers Against Drunk Drivers' Oakland County chapter.

"Christmas lights become a little less bright," said Greg Bien, chapter predicted. "People need help coping with the holidays. From now on, everything is bittersweet for them."

Donna Brokenshire of Troy said the holidays are especially difficult because her daughter, Kathie, who died in 1986 at 17, decorated their home for the holidays, each year. "We shard so much during the holidays," ste said. "We miss her but the warmth is still there. We know she is right there with us."

During the 90-minute service, "Candielight Vigil of Rememberance and Hope," 51 red ribbons were tied to 4 Christmas tree in memory of the 51 people, ages 15 to 99, who died in alcohol-related accidents in Oxkland County this year.

MADD came to Michigan in 1982 to offer courage and strength to families and friends coping with the loss of a loved one to a drunk driver. More than 23 vigils now are held annually around the state.

ACCIDENT VICTIMS whose names were read during the vigil

included 29 people, ages 13 to 58, from Macomb County. "These are the names of people who would be alive today if someone hadn't decided to drink and drive," sale blein, who lost his 4-year-old daughter, Nicole, in a 1981 alcohol-related accident. (See related story).

In 1981, 60 percent of all traffic fatalities in Oskland County were alcohol-related, Blen said. This year, the number has dropped to 43 percent.

"We're making an impact," said the seventh grade teacher from

He was referring to the public awareness campaign launched last week by Mothers Agalast Drunk Driving (MADD). Before the holiday campaign ends, more than 200,000 motorists are expected to fly the ribbons as a reminder to "Tie One On For Satety."

The feeling inside, however, goes deeper than any sense of satisfaction that comes with success—something Bien might be expected to feel as director of the Oakland County Chapter of MADD.

"When I see red ribbons waving all over the place. I feel my daughter's death has meaning." Bien said. "Nicky isn't gone if I remember her this way."

Bien said he and his wife, Penny, were walking with Nicole and

Christoplir, their 1-year-old son, about 7 pm, when a truck driven by a neighbor veered across the road and struck them from behind. Nicolt, 4, was dead at the seene. His wife was hospitalized after being lit and flipped, Blen said. The driver's blood-alcohol content was measured at .17, Blen said, ilmost twice the .10 at which drivers in Michigan are legally drant. The driver eventually went to jail:—"for about nine months," Blee said. He doesn't feel that was adequate punishment considering

Bies said. He doesn't feel that was adequate punishment considering the valless grief he and his family sub-equently endured.

"No amount of punishment will make up for the loss of my daughte," Bien said. "But the punishment is supposed to fit the crime, and nine months doesn't come dose."

"I felt so angry," he said. "I wanted to kill him (the drunk driver). But punishment was in the hands of the prosecutor, the judge and the lawyers." and the lawyers."
