

SF coaching rule stirs controversy

The repercussions from the case gainst accused child molester ames William Stoller are being felt the South Farmington Baseball

Stoller is the Southfield man

Stoller is the Southfield man charged with sexually molesting boys between the ages of 10 and 13 while he was a coach in the Garden City Youth Athletic Association. He is awaiting trial in Oakland County. As a result of the alleged Incidents in that league, the South Farmington board of directors passed a rule April 30 that will prohibit any adult without a child in the program from coaching or manging a team following the end of the 1991 regular season.

lowing the end of the 1991 regular season.

The rule would affect approximately 10 of the nearly 250 adults who serve as volunteer coaches or managers for the organization's 83 teams. South Farmington has some 1,200 children between 7 and 16 participating in its boys baseball and girls softball programs.

The rule has caused a furor within the organization. Those directly affected believe they have been unfairly singled out with no basis for such action, and league officials say they are being accused of conducting a witch bunt.

"WE JUST want to do things that protect kids." said Roxanne Pitzpatick, commissioner of the SFEC. "If we jumped on something because of the Stoller situation, then eruefy us. But we never did it to go after one person. If we acted too hastily because we're nervous, that's all they can get us on."

she and other board members were besieged by parents asking what safeguards the league had in place to protect their children.

Fitzpatrick asket local police about having background checks done on coaches and managers but was told it wasn't possible because of legal reasons, though it is done for people who sing up to participate in the Helping Hands program, she said.

The board decided the best alternative was to probabil people without a child on one of the SFE (teams from being an authority figure.

"We felt we would have more control if we had coaches with kids in the program." Fitzpatrick said.

"We're not saying all single people, are going to do anything to kids. All are going to do anything to kids. All registers of the way."

Geno Grabinski is one of the coaches affected by the rule. The 27-year-old former SFBC player is married and has no children, but he has coached in the league for eight years.

THERE HAS never been an inci-dent of coaches abusing players in the league, according to Fitzpatrick, and Grabinski has never been accused of any misconduct. But he doesn't like the doubt cast on his character by the new rule. "The way it sounded to me is we won't be allowed to coach because we're a risk," he said. "I think 'me being mistreated, I think we're being singled out. If they considered us a risk, why are they going to let us fin-

ish coaching this year? That makes no sense."

Grabinski said he and the other coaches affected have proved themselves to be worthy members of the organization. He said he coached the freshman team at Birmingham Bruther High School this year based on the recommendation of Farmington Hills resident and Rice varsity coach Ron Kalezynski, a former SFBC coach and parent.

"I REALIZE we may end up eliminating a lot of good people. But we looked at the whole Stoller situation and said. 'Maybe we need to keep a tittle more control over the people. If we made a rule that looks like an injustice to someone, we're sorry but we didn't do it to burt anyone. "I'm having a difficult time understanding why they can't see the good in us. They're only seeing the bad. It's as if I don't have enough to do, that I sat up all night thinking this up."
