

Hawks win showdown between area powers

David Davidson plays for Arizona State University now, but Farmington Hills Hawks remains an area power in girls tennis.

The Hawks proved that Friday when they defeated Livonia Stevenson 5-1 in a match between undefeated Western Lakes Activities Association (and top-ranked Overland) teams.

The Spartans were No. 1 and Harrison No. 2, but that will change when the new poll is released later this week.

Davidson, a two-time Class B champion, led Harrison to a pair of fifth-place finishes in state competition and the WLLA title last year.

The Hawks lost a dual meet to Stevenson a year ago but finished ahead of the Spartans in the WLLA tournament and won the league championship.

"This year we have the edge on them," Harrison coach Bernie Goldstein said. "I thought it would be closer, but our Nos. 1 and 2 singles players and first doubles team played as well as they could."

The Hawks, 9-0 in the league and 9-1 overall, have duals remaining against North Farmington and Plymouth Canton on Wednesday before attempting to defend their league title next Tuesday. Stevenson is 8-1 in the league.

Stephanie Schwalm, who replaced Davidson at No. 1 singles, defeated Holly Findling in two sets. Harrison swept the singles matches with Julie Heist, Lisa Tomlin and Jill Barringer. The doubles, also, Kristy Connell and Jodie Whitehead gave the Hawks a victory a No. 1 doubles.
