of the center line of Grand River Avenue; thence south 83° 15' east 815 feet parallel to and 20 feet north of the center line of Grand River Avenue; thence due north 400 feet to the end.

Section 1. Branch 1. Beginning on the Main Trunk of Section 1 at a point 8 feet east of the west line of Division Avenue and 20 north of the south line of Coolidge Drive in Fleming Roseland Park Sub.; thence north 1° 06' west 3772.3 feet parallel to the center line of Division Avenue to a point on the center line of Alta Loma Drive; thence north 7° 45' east 30.3 feet to a point on the north line of Alta Loma Drive extended said point being 6 feet east of the west property line of Division Avenue; thence north 1° 6' west 628.9 feet parallel to and 6 feet east of the west property line of Division Avenue to a point on the center line of State St.; thence north 29° 30' east 29.5 feet to a point on the north line of State St. extended, 5 feet east of the west line of Division Avenue; thence north 1° 06' west 216.3 feet parallel to and 5 feet east of the west line of Division Avenue; thence north 39° 45' west 710.3 feet to a point 35 feet due west of the southwest corner of the Lewis Budd property; thence due north 200 feet parallel to and 35 feet west of the west line of said property; thence due east 225 feet to a point 10 feet west of the east line of the Al Laing property; thence due north 468 feet parallel to and 10 feet west of the east line of said property to a point 20 feet north

feet parallel to and 5 feet east of the west line of Division Avenue to a point 42 feet south of the southwest corner of the intersection of Division Avenue and Grand River Avenue at the end.

Section 1. Branch 2. Beginning on the Main Trunk of Section 1 at a point 35 feet due west of the southwest corner of the Lewis Budd property; thence north 47° 0' west 1102 feet to a point 20 feet south of the center line of Grand River Avenue and 850 feet west of the west line of the Lewis Budd property at the end.

Section 2. Main Trunk. Beginning on the south bank of the River Rouge in the southeast one-quarter section 27, Farmington Township at a point 62 feet north and 50 feet east of the southeast corner of Grand River Avenue and Brookdale Avenue; thence north 50 feet to point at the intersection of the east line of Brookdale Avenue extended and the north edge of Grand River Avenue pavement; thence north 37° 30' west 3687 feet parallel to the center line of Grand River Avenue at a point 62 feet south of the face of the curb of the Grand River Avenue pavement and 10 feet west of the east property line of Division Avenue at the end.

Section 3. Main Trunk. Beginning on the north bank of the River Rouge in the southeast one-quarter section 27, Farmington Township at a point 35 feet east of the north and south quarter line of said section and 25 feet north of the center line of the Highway bridge where Powers Avenue crosses said River Rouge; thence north 45° 0' west 19 feet to the P. C. of a curve to the right with radius of 30 feet and central angle of 45°; thence along said curve 23.6 feet to the P. T.; thence due north 1186.4 feet parallel to and 5 feet east of the north and south quarter line of said section to the center line of Shiawassee Road; thence along the center line of Folkstone Avenue 1996 feet to a point 25 feet south of the center line of 10 Mile Road at the end.

Section 4. Main Trunk. Beginning on the left bank of River Rouge in the southeast one-quarter section 27, Farmington Township at a point on the south line of lot 67 Brookdale Subdivision 528.5 feet east of the southwest corner of said lot; thence easterly 566 feet along the south line of said lot to the center line of Brookdale Avenue; thence northerly 224.5 feet along the center line of Brookdale Avenue to a point 4 ft. north of the south line of lot No. 41, Brookdale Sub.; thence westerly 492 feet parallel to and 4 feet north of the south line of lots 41 and 34 Brookdale Sub. to a point 15 feet east and 25 feet south of the northwest corner of Cloverdale Avenue and Powers Avenue; thence westerly 600.8 feet along the center line of Cloverdale Avenue to a point 20 feet east of the west line of Maple Avenue; thence northerly 1486.6 feet parallel to and 20 feet east of the west line of Maple Avenue to the end.

Section 4. Branch 1. Beginning on the Main Trunk of section 4 in the southwest one-quarter section 27, Farmington Township at a point 15 feet east and 25 feet south of the northwest corner of Cloverdale Avenue and Powers Avenue; thence northerly 1100 feet parallel to and 15 feet east of the west line of Powers Avenue to the end.

Section 4. Branch 2. Beginning on the Main Trunk of section 4 in the southwest one-quarter section 27, Farmington Township at a point 15 feet east and 25 feet south of the northwest corner of Cloverdale Avenue and Powers Avenue; thence southerly 588 feet parallel to and 15 feet east of the west line of Powers Avenue to the end.

Section 5. Main Trunk. Beginning on the north bank of River Rouge in the southeast one-quarter section 27, Farmington Township at a point 15 feet north easterly from the northeasterly line of Grand River Avenue opposite the center line of the Grand Avenue highway bridge over River Rouge; thence north 27° 21' east 314.7 feet to the south corner, lot 44 of Re-subdivision of lots 106 to 110 and lots 119 to 151, Brookdale Subdivision; thence north 31° 17' east 497.5 feet along the southeast line of said lot 44 to the P. C. of a curve to the right with radius of 40 feet and central angle of 89° 57'; thence along said curve a distance of 62.8 feet to the P. T.; thence south 58° 46' east 206.5 feet along the center line of Valley View to the P. C. of a curve to the left with radius of 40 feet and central angle of 121° 27'; thence along said curve 84.8 feet to the P. T.; thence north 0° 13' west 543.4 feet parallel to and 30 feet east of the west line of Lakeway to the P. C. of a curve to the left with radius of 40 feet and central angle of 17° 22'; thence along said curve

a distance of 12.1 feet to the P. T.; thence north 17° 35' west 197.3 feet along Lakeway to the P. C. of a curve to the right with radius of 40 feet and central angle of 104° 52'; thence along said curve a distance of 73.2 feet to the P. T.; thence north 87° 17' east 406 feet along Cardigan Road; thence south 85° 10' east 492.6 feet along Cardigan Road to the P. C. of a curve to the left with radius of 40 feet and central angle of 93° 50'; thence along said curve 65.5 feet to the P. T.; thence due north 2418.8 feet parallel to and 24 feet east of the west line of Orchard Lake Avenue to a point 20 feet south of the center line of 10 Mile Road at the end.

Section 6. Main Trunk. Beginning on the north bank of River Rouge in the southeast one-quarter section 35, Farmington Township at a point 345.1 feet south and 200 feet west of the southwest corner of Grand River Road and Switzer Road; thence north 41° 30' west 95 feet to the P. C. of a curve to the right with radius of 50 feet and central angle of 41° 30'; thence along said curve a distance of 36.2 feet to the P. T.; thence due north 2913.7 feet along the center line of Tulane Avenue and the extension thereof to a point 10 feet south of the center line of Shiawassee Road at the end.

Section 6. Branch 1. Beginning on the Main Trunk of section 6 at the intersection of the center line of Tulane Avenue and the center line of the alley north of Grand River Avenue; thence north 59° 39' west 67.1 feet along the center line of the alley to the center line of Colgate Avenue; thence due north 87.7 feet along the center line of Colgate Avenue to a point 1 foot north of the south line extended of Lot 220 of Grand River Homes Subdivision at the end.

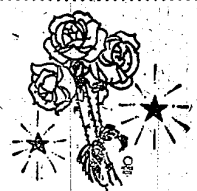

Beginning on Branch 1 of section 6 at the intersection of the center line of Albion Avenue with the center line of the alley north of Grand River Avenue; thence due north 2058.3 feet along the center line of Albion Avenue to a point 10 feet north of the south line extended of lot No. 141 Grand River Homes Sub. at the end.
