### LETTERS TO THE EDITOR

To the Editor:

President Coolidge, in his Fourth of July address of the year 1924, given before 15,000 delegates of the National Educational Association assembled in their annual convention, emphasized the necessity of religious training as the only safeguard of our country and the foundation-stone in the training of citizenship. Daniel Webster, undoubtedly the greatest American statesman, said: "Whatever makes men good Christians, makes them good citizens." And the greatest of all British statesmen, William E. Gladstone, said to his countrymen: "Try to make good, conscientious Christians out of your children, and Great Britain will be well satisfied with them as citizens."

Good citizenship and Christianity go hand in hand. In order that the boys and girls of today may become loyal citizens and staunch Christians of tomorrow, we must provide not only for their secular education, but also, and particularly, for their spiritual education. We know and realize the utter impossibility of giving a child a thorough Christian training by sending them to Sunday School once a week.

Something else is necessary to acquaint the child with all the important doctrines of the Bible. Something else is needed to give the child a good solid Christian foundation on which to build its moral character. Something else is indeed imperative to make the child realize the importance and value of religion.

That something else is a Christian day school, a school where your child's faith is not in danger of being wrecked, a school which can teach not only the three R's, but also a fourth—religion.

Such a school is St. Paul's Lutheran School which, during the coming term, will be conducted by Mr. R. Merkle from Concordia Teachers' College, River Forest, Ill. Parents wishing to send children, kindly consult the pastor, Rev. P. Graupner, corner Base Line and Middle Belt roads.
