Base sidewalks on wants, needs

t's tough to imagine city officials couldn't find a better way to spend several thou-sands of dollars than to build an unwanted

ands of dollars than to build an unwanted sidewalk along the east side of Farmington Road, adjacent to West Franklin Estates.

No, it won't completely ruin the lifestyle or destroy wildlife in that very rural subdivision to have the city install a sidewalk along the east side of Farmington Road. It is, after all, really only a sidewalk and it would be at the rear of the lots. That's not the point, though.

A couple months back, residents talked to city officials at one of the city's community based meetings. Plending their case, West Franklin Estates residents talked about a loss of ambience and the removal of trees that pro-

Franklin Estates residents talked about a loss of ambience and the removal of trees that provide habitat to a variety of wildlife creatures. They thought they'd won.

At that time, Farmington Hills Mayor Aldo Vagnozzi said the city had other ways to spend its sidewalk money — if the residents there didn't want it, they had plenty of requests from other parts of town that were eager to add sidewalks. Mayor pro-tem Cheryl Oliveria gareed.

Oliverio agreed.
So residents were surprised that their petitions – with signatures from more than 90 percent of the sub's residents opposing the sidewalks — weren't merely a formality when they presented them last week at a meeting with Tom Biasell, the city's public services director. Biasell told them he was there to discuss, listen and take their concerns to the

council.

Obviously, the sidewalk could benefit more than those people who live in West Franklin Estates. It could potentially serve all residents of Farmington Hills, not to mention West Bloomfield north of 14 Mile.

City officials should avoid trying to impose achieve the view of musting sidewalks.

City officials should avoin trying to impose a cookie-cutter view of putting sidewalks along all its main reads without paying close attention to how such a change affects life in the nearby subdivisions. There's value in maintaining the distinctive, rural character of some of the city's older areas, especially when such preservation it isn't dragging down prop-

erty values.
Sidewalks are already in place across the
street, on the west side of Farmington Road.
That should be enough to accommodate the that amount no enough to accommonate the pedestrians who might use that route, unless the city can show requests for sidewalks in that area by a number of residents or liability issues brought up by city attorneys.

Family issues will hold court

Startup is still more than five months away, but Oakland County is on target in its state-mandated quest to create a Family Division of Oakland County Circuit Court.

A new state law that took effect last fall, Public Act 388, requires chief circuit and pr Public Act 306, requires chief chief and po-bate judges to develop plans for a family div-sion within their local circuit court. The call for local family courts signals a growing belief that family matters indeed are important and demand the same quality of attention as crim inal and civil cases. About 30 percent of the cases that Onkland's 17 circuit court judges hear are family matters.

Overseers of Oakland's historic court reorganization are Edward Sosnick of Bloomfield Hills, chief judge of Oakland County Circuit Court, and Arthur Moore of Oxford Township, chief judge of Oakland County Probate Court. They've toiled with great purpose to set parameters for a Family Division, on course to hears its fiet goes in January. hear its first case in January.

Widely respected courtroom veterans, Sos-nick and Moore have looked to their judicial, administrative and support staffs to build the framework for Oakland's new family court. tramework for Oukand's new immly court.
They've sought advice from several sources,
including the county executive staff, the sheriff's department, the prosecutor's office, the
board of commissioners, Family Independence
Agency, Oakland Livingston Legal Aid.

Says Sosnick: "Oakland County has the

Says Sessing. Contain to county rule potential to be the model for the entire state. We have a unique opportunity to place children and families first, and our plan intends to accomplish that worthy goal."

A tribute to the diligence and leadership of A tribute to the diligence and leadership of Sosnick and Moore, the State Court Administrative Office recently approved their plan. It calls for six full-time judges within the Family Division, four from circuit court (Sosnick, John McDonnild of Farmington, Gene Schinelz of Novi, Joan Young of Bloomfield Township) and two from probate court (Moore and Wendy Patts of Birmingham). Probate Judge Sandra Silver of Bloomfield Township will serve in the division as coached. All how reputations for. division as needed. All have reputations for, above all, fairness.

The Family Division will combine domestic



relations cases now heard in circuit court (divorce, custody, visitation, child support, paternity) with juvenile cases now heard in probate court (abuse/neglect, delinquency, adoptions). Judges will be well attuned to available social services.

The emphasis on family means children caught in a divorce, for example, can gain immediate help to ward off delinquency and not wait for two different courts to work through the litigation. No matter how sweep-ing their problems, a family can expect to work with the same Family Division judge for

The idea behind a family court is rooted in The idea beanta a lamily dutt is routed the national debate on family values and salvaging the nuclear family. But a family court's role is far less political. Simply put, it limits instances where judges from different courts hand down rulings that affect a family without knowing how the other ruled.

without knowing how the other ruled.
Clearly, there's promise for the Family
Division of Oakland County Circuit Court to
stand as a model for responsiveness, accessibility and efficiency. In a county where
divorces and juvenile cases are on the
upswing, I'll watch intently how well the new
court lives up to its billing. Family matters
have too much impact on too many lives to be
relegated to circuit court deckets crowded with more-prevalent criminal and civil cases.

tance service such as your calls to Canad tance service such as your caus to Canada is exclusively under the jurisdiction of the Federal Communication Commission. However, in light of the potential for fraudulent practices on the part of a few of the long distance telephone companies, I have often relied on our consumer protection laws to prevent long distance companies from taking advantage of their sustances.

I believe that quite a great deal of the fraud can be reduced and/or remedied if consumers closely examine their bills and report any

closely examine their bills and report any errors to the service provider with a demand that the bill be promptly adjusted.

In the event that the consumer's attempt to resolve the problem by contacting the long distance company does not prove fruitful, I suggest that they contact the Consumer Protection Division of my office at (517) 373-1140 to make a formal complaint. I hope this provides caree information to you and your readers. some information to you and your readers.
