Hobbs takes business initiative

armington Hills officials have their work cut out for them. One of the city's biggest cut out for them. One of the city's bigges corporate residents, the S6-billion computer software giant Compusare, is facing continued growth and a need to expand. Sometime in the next six to 12 months, company officials say they'll make a decision on where those new facilities will be built. Compusare Chairman Peter Karmanos announced in a published report last month that he was fooking in earnest at Detroit as the place he wanted to be, with the idea of maving his company and its 3,000 employees. Soon after, company officials we interviewed backpedaled a bit. A spokesman said moving to Detroit was just one of the many options being considered, but he noted that it was "wastly premature" to say the firm is definited to the content of the content of the said of the content of

That seems to leave the window of opportu-nity slightly ain for city officials. And they're planning to take advantage.

City Manager Dan Hobbs sounded emphasi-city for the first paragraph of the control of

ic at a meeting of the Interagency Council of Farmington/Farmington Hills two weeks ago: "We're not going to lose them." He said he had spoken to Compuware officials who said the published report was "overblown." Hobbs also pledged to team up with Mayor Aldo Vagnozzi to meet with Compuware officials to see what could be done to convince the control of the country could be done to convince them to stay or build elsewhere in Farmington Hills.
It wouldn't be fair to say Farmington Hills

officials are making some kind of knee-jerk reaction to the Compuware situation, Actually, back in February, Hobbs' state of the city report outlined the need for a new city administrator – hired within the current number of employees — to focus on economic develop-ment. Topping his listed needs were "business retention" followed by "looking for opportuni-ties to expand existing businesses," according

The reasons are simple. Farmington Hills' tax base is more than one-third commercial meaning 36 cents of every tax dollar that pays the cost of police, fire, trash services, parks, local roads, etc. comes from the business community. Every new business investment — like the new Calsonic North America head-

like the new Calsonic North America head-quarters and testing facility that hosts a grand opening this week (you can read about it in Sunday's Observer) — boosts commercial tax base and means homeowners pay less. Focusing on economic development shouldn't mean giving businesses everything they want and trampling homeowner rights. On the other hand, a community can't ignore the needs of its commercial residents.

This isn't the first time Farmington Hills has seen one of its bigger business residents looking toward Detroit for a new headquar-ters. Former Mayor Ben Marks, who listened to Hobbs' comments on retaining business during the Interagency meeting, recounted how he woke up one Monday morning a few years back to find out that Little Caesars was relocating its pizza operation to Detroit. "Don't

relocating its pizza operation to Detroit. "Don't get lulled into a false sense of security like we did with Little Caesars," Marks said. Hobbs' focus on economic development and business retention shows he isn't taking for granted Farmington Hills' rich commercial tax base. Now, we'll see if he can meet his pledge of keeping Compuware here.

Common quest helps them help others

olor it compassion. That's the impetus behind an Oakland County human service agency whose volunteers are grounded in a common quest to help people prevent and cope with crisis, however imminent.

Called Common Ground, the 24-hour crisis Called Common Ground, the 24-hour crisis intervention center has been dispensing a commonly sought elixir for survival since 1970. As services grew over the years, the headquarters moved from Birmingham to Royal Oak to Pontiac. But the agency's mission hasn't changed: to help people escape from an emotional briar patch.

Oakland County Community Mental Health, plus public and private grants, fund Common Ground's nearly \$2 million budget. The biggest fund-raiser: Birmingham Art in the Park, held each September in Shain Park. Common Ground came away with upwards of \$95,000 on Sept. 6-7, thanks in part to the spirituality of healing that fine art and a kind heart evoke.

Common Ground's signature service is round-the-clock telephone crisis intervention. Staffers and volunteers trained in tackling mental health concerns take 20,000 calls a year from people at the brink. Counselors practice timeliness and caring amid hysteria and tears. They tap an information and refer ral library to provide telephone numbers and facts from 4,500 community and professional resources. Walk-in counseling is available, too.

Related crisis intervention services include a victims' assistance program, a legal clinic and youth interaction programs. Community out-reach and training deal with crisis intervention, workplace stress, suicide, parenting, self esteem, child abuse and sexual abuse.

Common Ground also is the coordinating agency for the Oakland County Crisis Response Team, formed in the wake of the 1991 Royal Oak Post Office shootings. The team assists groups or communities struggling to withstand the claws of a crisis.

Common Ground volunteers bring a range of social experiences. They know how to care,



alm and communicate. They aren't experts. but have on-site access to social workers, nurses and psychiatrists. They can get imme-diate help on suicide prevention, rape counseling, domestic violence and drug rehabilitation.

ham-Bloomfield hotline started in 1969 main-ly to help teens battle substance abuse. Then ly to help teens battle substance abuse. Then as now, volunteers included young people dedicated to helping themselves and their peers—creating a common ground from which to turn their lives around. Then as now, drug and alcohol problems were grave concerns, although the age range of typical callers has shifted from 18 to 20 to 30 to 50, a byproduct of school teen counseling services.

A key new Common Ground service offers emergency psychiatric screening, treatment and referral. Another is the Common Ground Phone Card — a 60-minute, rechargeable card selling for \$20. More than 37 cents of every dollar raised by the card are ticketed for telehone crisis intervention.

For 26 years, Common Ground has helped stand sentry over Oakland County residen — spurring them to find hope, courage and energy amid darkness, fear and lethargy. urage and
