## Inch, Webb: 2 proven leaders

nck Inch and Cathy Webb have shown the leadership and leadership and commit ment needed to serve as trustees of the Farmington Public School District. Voters should re-elect both incumbents on Monday

June 8.
As the two longest serving board members, Inch and Webb offer a combined 28 years of knowledge and understanding of board issues and history. That experience will continue to serve the community well in the future, as it has in the

The district has a number of points of pride in recent years, and many of those issues involve listening to the community. A

few years back, the district began putting an emphasis on offering middle school youngsters something to do in those critical after-schoolbut-before-the-folks-get-home hours of 2:30 to 5:30 p.m. Now, it has four after-school teen

5:30 p.m. Now, it has four after-school teen drop-in sites with busing provided. At the same time, district students maintained relatively steady test scores, moved toward inclusion and expanded choice options. The district has also tried to ensure equity and access for all students, cultivated a broader acceptance of all cultures and races, and expanded the role that the business communiexpanded the role that the business com ty plays in education. Ask Realtors, this is a district people want.

If anyone deserves credit for these efforts

and accomplishments, it's the school board. And that includes Inch and Webb.

It's easy to nitpick people who have been nabashed advocates of education and leaders

on the board. This newspaper hasn't always agreed with every decision or vote of both incumbents. Most recently, we differed with Webb – and agreed with Inch – on the decision Webb - and agreed with inch - on the decision by the board to spend about 20 percent of the Durant lawauit money that was returned to the district, and only give 80 percent of the money back to voters as a tax reduction.

On the other hand, we supported the district's bind issue drives of last year. And we credit the board members - including Inch.

and Webb - with listening to the voters' rejecand Webb – with listening to the voters' rejec-tion of the first \$110 million request by trim-ming the total size and offering two choices for voters the second time the issue was put on the ballot. Voters agreed too.

Inch and Webb offer different styles and specialties. Neither one, however, has been afraid to vote against the rest of the board or take a stand.

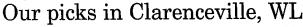

Inch brings a cut-through-the-crap style that many say helps frame debates and issues He's an educator who defends an educational He's an educator who detends an educational bureaucracy that some critics find an easy target. Why so defensive? Ask questions later, he says, so as not to embarrass or find a scapegoat in public. He's also dead-set against board micromanngement. Mostly, those are admirable qualities.

admirable qualities. Webb is well-respected both in the educa-tional community and beyond. She's very accessible and strongly touts the district's role in developing responsible citizens as well as academic achievers.

We are also impressed with newcomers Shaw, a Walled Lake educator who has lived in the district since 1985 and Waack, a licensed nursing beam administrate and the state of the state licensed nursing home administrator who has daughters in the district.

These candidates offer a thoughtful, level-

headed viewpoint, something that's needed

For residents in northwest Farmington
Hills, in the Walled Lake Consolidated School District, we endorse incumbents Thomas McConnell and Randolph G. Ston.

Incumbents Ston and McConnell not only have experience with redistricting as board members, both voted down the current redis-tricting plan because they believed it could

tricting plan because they believed it could have been done better.

They also have offered some unique suggestions on growth, showing a strong desire to involve the community in various issues.

McConnell suggested building elementary

schools for lower grades instead of redistricting. And both candidates support constant study of the rising population, involving residents, to make well-informed decisions about

where children will be sent to school.

All of the candidates are qualified and have children in the district. But we believe the incumbents, McConnell and Ston, have demonstrated their ability to act in the best interests of the district.

### Find ways to hike voter turnouts

Any day now, state representatives will take up a package of bills designed – so some say – to encourage higher turnouts in school elections. Western Wayne County's Sen. Loren Bennett, R-Canton, is sponsor of part of the package.

We see flaws in the package and warn the

ouse to make key amendments.

The idea of higher turnouts is laudable. We have seen some turnouts in June elections as low as 3 percent; it's so bad that anything over 10 percent is considered great; and a turnout of 25 percent is volcanic.

A low turnout allows special interest groups to tilt the results, It's not necessary to name

particular ideologies or unions.

The Senate bills would schedule school elec tions in November of even-numbered years. That would be bad. That ballot already is too long, with congressional, state, legislative, counties, townships, trial judges, appellate judges, State Board of Education, state uni-

yersity boards and state ballot proposals.

School board elections would wind up at the bettom of the nonpartisan ballot, utterly lost.

The Senate bills, if adopted, would assure us of higher turnouts but at the terrible cost of loss of voter interest due to "ballot fatigue."

Here's what we see as an ideal school elec-

Lump all education elections into one ballot - State Board, three universities, commu-nity colleges and local school boards - perhaps in May. Education would be the sole focus. School people dislike the idea of mixing parti-san state with nonpartisan local elections. That concern is without morit. Much more would be gained through making education

the sole focus.

Confine elections to four dates per year

■ Confine elections to four dates per year—
say, a Tuesday in February, May, August and
November. School boards seeking bond issue
approval could pick from those four dates. No
more odd dates to wear down the public.
■ Put cities and townships in charge of all
elections, including schools. At present, Michi
gan has a hodge-podge system. The result is
that some folks vote on school issues in their
cities to tayschip presided; while attent system. city or township precincts, while others vote in different school precincts. There is no excuse for requiring voters to remember two different voting precincts. This last proposal alrendy is

voting precincts. This list proposal aircady is in the Senate package.

As a rule, Michiganians are peppered with special elections on special dates. Some school administrators and unions like it that way, because they can get "their people" out to vote. Where such an attitude exists, we deplore it. Education is too important an issue to warrent a newern turneut or to place at the botters.

Education is too important an issue to win-rant a 3 percent turnout or to place at the bot-tom of a bedsheet ballot.
