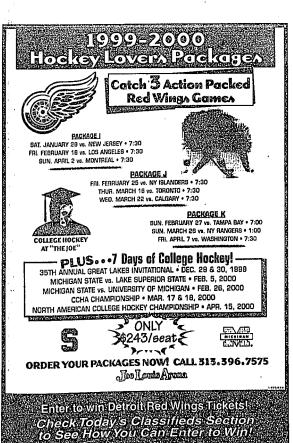
Woiss ran to the two, the Raiders were stopped for no gain and followed that with a delay of game penalty before Weiss ran it in from the eight.
