

Trojans win showdown over Warriors

The boys basketball season is starting to look a lot like last fall's football season at Livonia Clarenceville.

The Trojans won their eighth straight Tuesday with a pivotal 69-60 road win at Lutheran High Westland in a battle of Metro Conference unbeatens.

Clarenceville is 9-4 overall and 5-0 in the Metro. Another win Friday at Macomb Lutheran North would set up a showdown Feb. 8 at home against Hamtramck (7-3, 4-0), the conference's only other unbeaten.

Scott Wion, who helped the Trojans to a 9-1 football record and first-ever state playoff berth last fall, flexed his muscles inside against the Warriors. The 6-foot-4, 240-pound center finished with a game-high 20 points to go along with 11 rebounds.

"Scott got off to a slow start this year because of football, but he's getting better each time out and starting to play with a lot of enthusiasm," Clarenceville coach Bill Dyer said. "Coming out of football, I think it took us awhile to get going as a team. But

because of their success in football, these guys, especially the seniors, have a lot of pride and they think can compete. It's been a big plus."

The Trojans beat Lutheran Westland (5-4, 4-1) without key sophomore Tim Shaw, the 2,000-pound ground grinder. The 6-2 Shaw, the team's best leaper and starting forward, sat out the game with a sprained ankle after injuring it last Friday against Harper Woods.

"You don't think I was a little nervous going into this game without Tim because he's probably our best defensive player and he can jump out of gym," Dyer said. "But Joe Kough (eight points) started and played fantastic. He gave us a huge lift. We missed Tim's size, but we really didn't miss a beat and we were able to do the things we normally do. Joe's been around for two years and he knows what he's doing."

Point-guard Corey McKendry contributed 14 points, including eight of 10 free throws in the final quarter to help quell a late

Lutheran Westland run. Forward Rick Burack chipped in with 11.

"For being depleted, Clarenceville did a nice job," Lutheran Westland coach Dan Ramthun said. "They play well together. They mix up their defenses pretty well between man and zone, and we really didn't respond well to it."

The Warriors led 10-8 after one quarter, but Clarenceville took a 22-16 halftime lead thanks to a last-second basket by Bill Fillinger.

The third quarter was all Clarenceville.

The Trojans limited Lutheran Westland to a pair of field goals and two free throws on route to a 17-8 run for a 39-22 advantage.

"More than anything we told our kids to keep playing hard," Dyer said. "We mixed things up defensively. This is a great group of kids because they think they can play defense."

Although stymied by poor shooting (8 for 28) and turnovers (17) through three quarters, Lutheran Westland refused to fold.

The Warriors pulled to within four, 46-41, with 3:08 remaining

on a three-pointer by Luke Kasten.

But Wion slipped inside for two easy points and McKendry and McKendry each made a free throw to stop Warriors' rally.

"We got to the point where we had to go man-to-man, look for traps and steals, you've got to gamble," Ramthun said. "I admired the way our guys cut it to four."

"The last three games we've gotten behind at the half and you can't do that against Clarenceville. They also hit their free throws."

Senior guard Charlie Hoeft, the Warriors' leading scorer, tallied 12 of his 16 in the final quarter. He was five of 16 from the floor. Nate Meekins, a 6-7 junior center, also scored 16.

But the inside battle was won by Wion, the Trojans' tight end and linebacker.

"He's good," Ramthun said. "We'd collapse our zone around him and he still finds a way to get it in the zone. We didn't play him real well."

Dyer hopes another footballer is ready for Friday.

"Tim is a tough kid; I think he'll be back on Friday," he said.

of 14 fourth-quarter shots after shooting a sizzling 55 percent (15-of-27) from the floor in the first three quarters.

"I told the kids we had a great chance to win this game, but we just couldn't get the ball to go down in the fourth quarter," Canton coach Dan Young said.

"We had open looks down the stretch, but we had a couple go in and out and Farmington made its shots. We couldn't buy a three (point basket) in the fourth quarter."

"Young said his team's 23 turnovers was the result of the Falcons' in-your-face defensive pressure.

"You can't turn the ball over that many times and expect to beat a good team like Farmington," Young reiterated. "But (the Falcons) were the reason we turned the ball over so much. They're quick and they have long arms, which makes it difficult."

Senior forward Chad Seaborn engineered the Falcons on the offensive end of the court, scor-

ing 16 points, including three triples.

Justin Milus was Farmington's go-to guy in the paint, racking up 14 hard-earned points inside along with a team-high six rebounds.

"I was especially pleased with the job Justin did defensively against (Jason) Waidmann," Mikel said. "He made (Waidmann) work for everything he got."

Canton junior forward Kenny Nether turned in a solid effort, pouring in a team-high 15 points while grabbing a game-high 10 rebounds. Waidmann excelled, netting 13 points, nine boards and four assists.

Canton senior forward Dan McLean was well on his way to having a huge night before suffering a strained knee with 5:11 left in the first half.

McLean, who tallied six first-quarter points, did not return after being assisted off the court by Canton coaches.

Paced by McLean's offensive

exploits, Canton led 14-7 after one quarter. The Chiefs' biggest lead of the night came 25 seconds into the second quarter when Waidmann muscled in a layup to put his team up, 16-7.

Sparked by Seaborn outside and senior center Brian Davies inside, the Falcons stormed back to take a short-lived, 21-20 lead with 30 seconds left in the first half. But two free throws from Nether gave the Chiefs a 22-21 halftime advantage.

A Waidmann layup put Canton up, 34-27, at the 4:19 mark of the third quarter, but Farmington answered with a momentum-changing, 10-0 flurry.

Milus accounted for half of the points in the key run, igniting it with a three-point play and finishing it with two free throws.

Two Nether free throws tied the score at 43, but Farmington spoiled any hopes Canton had of pulling off the mild upset by scoring the next six points.

Seaborn started the game-winning rally with a 10-foot jumper

off the glass with 3:20 left to give the Falcons a 45-43 advantage.

Milus bit a short jumper from the baseline seconds later to put the Falcons up, 47-43, and Michael Griffie delivered two free throws with 1:29 left to make the lead six.

Nether buried a long three with 25 seconds left to bring Canton to within 51-46, but it was too little, too late.

The Falcons shot 35 percent (17-of-58) from the floor and 62 percent (9-of-16) from the free-throw line.

The Chiefs hit 41 percent of their field goals (17-of-41) and 60 percent (9-of-16) from the free-throw line.

N. FARMINGTON 56, FRANKLIN 48; Livonia Franklin (4-0, 2-4) put up a tight Tuesday before succumbing to WLLA (triple threat Farmington (7-5, 4-1).

"We played well, we just needed another person to step up and score, but that was due to North's defense," Franklin coach Dan Robinson said.

Franklin junior Joe Ruggiero led all scorers with 23 points. Chris Patterson added nine.

Brian Seaborn and Emil Merdjanian led a balanced North scoring attack with 16 points apiece. Merdjanian also grabbed seven rebounds. Phil Watila added 15 points, while Adrian Bridges added all seven of his in the second half.

BURGESS 83, REDFORD 68 (OT): David Didlake scored 25 points Tuesday, led Bishop Burgess (9-4, 4-3) to an overtime win against host Catholic Central (7-0, 5-2).

Burgess averaged a 105-83 loss in the school's first meeting this year.

Didlake scored five in overtime while George Toles scored six of his 23 in the extra time. Toles backed in a three-pointer, stole the ball and whistled in a triple at the buzzer to decide the game.

The Spartans built up leads of 19-11 and 40-30 at the end of the first two quarters, but the Spartans shaved five points off the margin in each of the last two periods.

CC scored and held Burgess off at the end of regulation to force OT.

Junior Bryan Galeski led CC with 16 points. Senior Rob Sparks had 14; juniors Mark Willoughby 13 and Anthony Coratti scored 13 and 12. Senior Rod Hunt added 10.
