He had installed smoke-eaters or air handlers at many of his sites and has mixed results. Both types mix outside air with the inside air in a recycling action called "make up air." This helps a lot, but only if the required maintenance is kept up. As a proprietor, Voight real-izes that to ban smoking would result in a loss of customers.
