Prospects dim for future of C'ville community ed

In concept, community education is a great idea: It expands education and learning across a school district from only focusing on children between the ages of kindergarten and high school to a much wide audience.

However, districts facing community education programs that are pulling money away from K-12 programs and aren't serving residents of the communi-ty – which is the situation facing Clarenceville – must step back and recognized.

By setting up a task force to study its community education programs, school district officials in that small district, which covers parts of Livonia, Farmington Hills and Redford, took the first step. Now that the group has reported and recommended changes comes the tough-

Now that the group has reported and recommended changes comes the toughest part.

Several board members have already made up their minds. Trustees Bryan Bentley and Gary Garrison voted against continuing community education programs in Clarenceville last week, after seeing the writing on the wall: Barely more than a quarter of the community education classes are taken by residents; in addition, it's costing the district \$20,000 a year to subsidize community education programs.

It has become customary for school districts to espouse the idea of life-long learning, aiming to serve its residents from nearly the cradle to the grave. It's a standard of district mission statements.

One key component of the theory is that a school district should serve all of its residents, not only those pupils in the K-12 grades. Community education has generally found a niche in offering residents a chance to learn things like crafts, howe remedialing, vega. Finances, wim-

Dropping something as valuable as community education should not be something taken lightly, especially since starting it back up again would seem near impossible especially in the current school funding climate. Legislature should take a new look at tech bill

The fact is, though, that similar legislation is on the agenda in states from New York to California. The New Jersey Secretary of State has accepted electronic signatures for drivers license renewals since 1999. In Newada, most routine transactions between residents and their state and local governments allow electronic signatures.

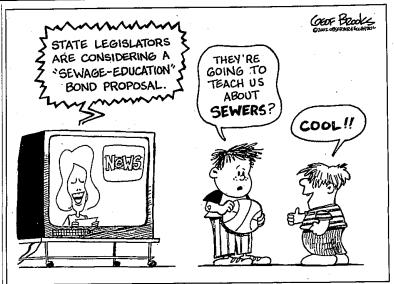
Michigan residents can renew car, boat and snowmobile registrations online with no signature required.
