PLEASE TAKE NOTICE that the regular election for the Farmington Public School District will be held in the School District on Monday, June 10, 2002.

Act 451, Public Acts of Michigan, 1976 as amended, provides in part as follows:

The inspectors of election at a regular or special election shall not receive the vote of a person residing in a registration school district whose name is not registered as an elector in the city or township in which the person resides.

The last day for receiving registrations for the regular election will be Monday, May 13, 2002. Persons registering after the Clerk's office closes, on Monday, May 13, 2002, will not be eligible to vote at the regular election. Persons planning to register must determine when the Clerk's office will be open for registration.

Only persons who have registered as general electors with the appropriate Clerk of the City or Township in which they reside, or through registration at a Secretary of State drivers license bureau, or at certain school district buildings are registered school electors and registered community college electors.
