# Left-turn signals should be a priority

Is it time to look at adding more left-turn signals?

is it time to look at adding more left-turn signals? Those green arrows turn to yellow as they allow left turns, while other drivers at the intersection are stopped for red lights. According to Farmington Public Safety Director Gary Goss, they've made a huge difference in reducing accident rates at three of the community's major intersections.

It's tough to argue with additional strong evidence that shows that these left-turn signals alone have a huge effect on improving safety.

One on-going AAA study shows that adding only those left-turn signals can cut total crashes (property and injury) by 30 percent, and they cut injury crashes by more than half. Most important, the signals slash the number of head-on, left-turn collisions by a whopping 69 percent. And those are the accidents that usually end in the most scrious injuries or deaths.

The study also shows that left-turn signals disproportionately help out two groups of drivers: Those very young drivers — people with good reflexes but little experience, who often make poor driving judgments, and those older drivers — people with have plenty of experience, who often make poor driving judgments, and those older drivers — people who have plenty of experience but slower reflexes, according to AAA officials.

Of course, drivers today arent what they used to be. In the "good old days," a yellow light really meant something, and people making left turns actually got a chance to make their turn without being endangered. In those days, left-turn arrows were a rarily.

Today, were all in a huge hurry, distracted by CD players and cell phones, and it seems those left-turn arrows have become more than a convenience. Many of us have gotten used to those left-turn signals that are already installed at many of our busiest intersections. Heek, they make us feel safer, don't they?

fortunate.

Often, the insurance company substantially reduces the billing because the provider participates with the insurance company. As a parent of four children enrolled at Our Lady of Sorrows School I wanted to share my experiences with the readers and editors of the Observer after reading the many articles on the subject this past Surviva:

During the (Nov. 7 final grade level) meeting 1 had the opportunity to ask the following three questions of school principal James Watson and Monsignor Walter Hurley:

1. How will the content of art, music and physical education elasses change if shared time is implemented?

Mr. Watson responded that he has reviewed the curriculum and the document is "about this thick" (holding his thumb and finger to indicate a few inches). He offered to pravide an executive summary that could be published in a future school newsletter. To date, no summary has been provided.

2. The Farmington School District Board members stated that they needed to see a strong level of support from the requesting community in order to move forward with the shared time program. How does the OLS administration planto demonstrate this support?

Msgr. Hurley replied that a meeting would be scheduled with Dr. Maxfield. At that meeting, Mr. Watson will inform Dr.

Maxfield that OLS intends to move for-

ward with the shared time program.

3. At the suggestion of the Farmington School District Board I volunteered to be a part of any committee that is formed at OLS to discuss shared time. Will those

OLS to discuss shared time. Will those meetings be held?
Monsignor Hurley replied that no focus group meetings would be held and no votes on the issue would be taken. He further said that these grade level meetings were being substituted for any committees that may have been referenced in the past. He told the group in attendance that he elected not to invite any representation from the Farmington School District.

Later in November, Mr. Watson wrote the following to parents in his newsletter: "Of the 177 parents attending, about 40 people expressed sentiments against shared time, and I respect their opinions and right to disagree. Of those opposed, about 30-33 people were able to discuss some legitimate questions in a thought-ful. appropriate manner.

Mostly, we would like more information about the curriculum and how it might be implemented at OLS.
