Consultants have identified downtown Farmington's biggest problem, which should come as a surprise to no one. We have two 'downtowns' - the historic corridor on Grand River and the Downtowns' - the historic corridor on Grand River and the Downtown Farmington Business Center, which local residents have complained is becoming Discount City with the addition of Bargain Books, a Dollar Store and other deep discount chains.

It would be easy to give up, using the argument that the Center's corporate owners can't be forced to revamp their tenant list. Their bottom line is - and should be - keeping their stores occupied and turning a profit.

Instead, Main Street has opened up the floodgates of creative thought. Consider what might happen if Farmington marketed the entire downtown business district to create a waiting list of prospects, available whenever a space opens up. Consider the possibilities for vast wealth of city-owned parking lots, which could be developed in a configuration that would invite pedestrian traffic.

It seems to us the image developing in the mists of a new beginning is one of cooperation, not confrontation, of promotting possibilities rather than fearing what we have never before done.

The possibilities seem limited only by the collective imagination of those who get involved in this process. The folks who sacrificed valuable time and energy last week deserve a word of thanks for stepping up to the plate.

### **Donations needed by** charities year-round

Needy families don't get hungry or cold just on Thanksgiving and Christmas.
That's why it's important to donate to charities throughout the year.

"People are in need all year long," says Rosellen Loye-Bucy, executive director of Lighthouse Emergency Services for more than three years.

Moet of us get into the Christmas spirit during the holiday scason, contributing gifts to Toys for Tuts, dropping coins in Salvation Army kettles, adopting a family through Lighthouse Emergency Services.

It makes us feel good to help our fellow man — and we get a year—and tax deduction to boot.

Yet most charitable organizations — Lighthouse, the Salvation Army, United Way, etc. — depend on contributions year-round to help needy families the other 11 months of the year.

Lighthouse, for example, conducts a peanut butter and jelly drive in the spring os struggling families have something to serve their children for hunch during the summer when they can't eat subsidized school hunches.

Lighthouse gets about 5 to 10 percent of its donations during the holiday scason, and much of that goes toward food baskets for holiday meals, says Loye-Bucy. Yet the agency needs contributions to assist needy families and seniors with prescriptions, utility bills, groceries and other ongoing expenses.

The Salvation Army gets about 60 percent of its fund-

agency needs contributions to assist needy natures and other ongoing expenses.

The Salvation Army gets about 60 percent of its funding at Christmastime, says Tanya Naumenko, director of public relations for the Salvation Army's southeastern Michigan division. 'We still need to raise the other 40 percent. The less funding we get, the less programming we can do.'

This year, it's even more important to extend charitable giving past the holidays.

Unfortunately, he failed to shine a light on the largest accounting scandal in the history of the United States and the culprits behind in the Buseness of the Public

As of Jan. 2, the Bureau of the Public
Debt reports \$3.6 trillion as publicly-held

debt in the form of treasury bills, notes, and bonds. In addition, the bureau reports \$2.7 trillion of intragovernmental debt. For the mathematically-challenged in Washington, this totals \$6.3 trillion. In addition to underreporting the debt, politicians lied about a budget "surplus." For the past few years, Americans were told government income exceeded expenditures for the first time in decades and the government paid off some of its obligations. The government did pay off some of the third pay off some of the publicly-held debt, but at the same time increased the intragovernment.

same time increased the intragovernmen-tal debt.
From fiscal year 1997 to 2002, the national debt rose each year from \$5.4 trillion to \$6.2 trillion. I wonder how much debt we would have accumulated without the "surplus"?
Now if \$6.3 trillion seems rather large, brace yourself. Liabilities include all financial obligations, not just the amount of debt. For corporations, examples of additional liabilities include retirement and insurance benefits to be paid in the future.

and insurance benefits to be paid in the future.

The Social Security Administration reports their fraudulent trust fund has a long-term unfunded liability of \$22 trillion while Medicare's unfunded liability stands at \$17 trillion. While future reforms such as personal rocial security accounts and medical savings accounts could reduce these liabilities, the lack of honest dialogue between Republicans and Democratis offers little hope for the near term.

To put this into perspective, Worldcom over-reported earnings by \$7 billion while Washington underreports its liabilities by over \$40 TRILLION. But Washington's accounting malfeasance doesn't stop there. The General Accounting Office discovered \$7.7 billion in unreconciled transactions last fiscal year. This means the federal governent could not account for more money. ment could not account for more money than Worldcom and Enron misstated as

than Worldeom and Enron misstated as earnings.

In addition, Congress plays with the books to avoid spending caps. When trying to avoid the eap, Congress will declare expenditures as "oll-budget" or classify them as "emergencies" or "move" expenditures into the previous year to free up more money for the current year. So while Congress attacks corporate America and demands accountability, they turn a blind eye to their own abuses. Does this somehow forgive the decett and fraud committed by a few corporations? Absolutely not. Executives should be prosecuted and, if found guilty, thrown into prison.

into prison.

But at the same time, let's send them some cellmates from Washington. Let's restore confidence in the economy by applying the same standards to government officials as corporate executives.
