NEW METHOD OF HANDLING SCHOOL CASH IS ADOPTED

Recommendations of Audit Committee For School Office Approved

A series of recommendations intended to provide a complete book-keeping system in the office of Farmington Public Schools, and give the Board of Education a closer check on handling of finance and other matters in the office, was adopted by the Board at its regular meeting last Thursday evening. The recommendations were made by Mrs. Florence Lee, secretary, as reporting as an audit committee.

In making her report, Mrs. Lee emphasized that there is no discrepancy in finances, but that the Board was led to make a study of the system in use, by the fact that five school boards in Michigan are now under fire, due to difficulties in handling of finances. It is to avoid any such situation in Farmington in the future that the new system is advised, Mrs. Lee stated.

The recommendations are as follows:

1. All money received in the school office belonging to the District is to be given to the Secretary, who will turn it over to the Treasurer, the latter depositing it in the banks. This includes money received for text-books, tuition, school supplies, sold to pupils, and the music fund.
2. A complete set of books is to be kept on these funds.
3. The School office is to furnish the Board of Education with a complete report of these items.
4. No bills are to be paid by the office except from the petty cash fund.
5. The school office is to furnish the Board with a complete report of all text-books purchased, the buying and selling price of each. The selling price is to be based on the buying price plus eight.
6. A list of all books, with buying and selling prices is to be kept posted on the bulletin board so that pupils and patrons of the school will know that books are not sold at a profit.
7. No text-books are to be charged.
8. The petty cash fund is to be used for small bills only and a complete report of petty cash expenditures is to be made to the board before the petty cash fund is renewed.
9. The secretary and treasurer are to be furnished with a complete list of all tuition pupils and the amount to be paid by the district and the parents for each pupil, so that the Secretary and Treasurer will have a check on tuition at all times.
10. Mrs. Lee and Treasurer Arthur Lamb were appointed as audit committee at a meeting of the Board on January 16.
