An Open Forum For Farmington?

To the Editor: It is a good augury for America that the open forum method of discussing public questions is still popular among us. It is Education in the best sense of the word—challenging, critical, creative. It stirs up thought, breaks down prejudices, and opens our minds to new ideas. By getting our information first, hand—by considering all views, and consulting all opinions—we learn to distinguish Good from Bad, and we come nearer to the Truth. Since most of the schools, churches, and newspapers, and citizens' organs of public enlightenment, are predominantly organs of majority opinion, and impress upon the public mind the conservative side of social, political, and economic issues, the open forum—set up as an organ of minority opinion and freedom of speech—can serve a unique function in community life. The open forum is of great educational value in the formation of intelligent public opinion, and every progressive community should have one.

With these ideas in mind, a mass meeting has been arranged for Saturday evening, October 29, at 8:00 p. m. in the Universalist Church of Farmington. We will follow the open forum method, and the subject for discussion will be: "Capitalism versus Socialism." Two able speakers from Detroit will present their views, after which there will be a period for questions and general discussion. Any member of the audience may ask questions, and express his own views, for or against, if he so desires.

If this meeting is successful, we may hold more in the course of the year. We would be glad to get in touch with anyone interested in organizing a discussion group or open forum in Farmington.

COUNTY ART EXHIBIT SET FOR BIRMINGHAM ON NOVEMBER 18-20

The Oakland County art exhibit, sponsored by the Oakland County Federation of Women's Clubs, will be held at the Community House, Birmingham, Mich., on November 18, 19, and 20. It will be open to the public from 2 to 9 p. m.

Artists, professional and amateur, who reside in Oakland County, are requested to contribute to the Exhibit.

Conditions of the exhibition are: Original works of art such as oil paintings, water-colors pastels, etchings, black and white drawings, also sculpture, clay models, wood carving, etc., which have a distinctively artistic value, will be accepted for exhibition.

A special room will be set aside for unframed works. Pictures must be provided with suitable arrangements for hanging. The name and address of the artist should be marked on the rear of each picture, as well as the selling price, if the picture is for sale.

No needs work will be accepted for exhibition this year. A charge of 25 cents will be made to each artist for one to three objects placed on exhibition, and 10 cents extra for each additional object. No more than five pieces of art will be accepted from one artist.

All works of art must be brought to the Community House on Wednesday, November 16, and not later than noon of the 17. A receiving committee will be in charge, to register the names and addresses of artists and the title and value of each object received.

Insurance will be provided for a very small charge, as the Federation or the committee in charge assume no responsibility for damage or loss.

All objects must be promptly called for and removed by the exhibitors on Monday, November 21, and no later than noon of the 22, as the committee in charge will discontinue its duties at that time and the insurance will be cancelled.

A vote will be taken to ascertain the five most popular works of art at the Exhibit and letters of recognition given to the favored artists.
