1/2 teaspoon salt.

Two tablespoons flour.
Meat slices.
Cook together first five ingredients. Strain. Melt butter, add flour and blend thoroughly. Add tomato mixture slowly and bring to boiling point, stirring constantly. Arrange meat on a hot platter and pour the boiling sauce over it. Brown gravy may be used in place of tomato sauce.

Taking the Stand
You will be delighted to take the stand any time—and "tell all," if you have the opportunity to talk about something as delicious as Meat Souffle. Before you know it, you will be bragging—in a well-bred way, of course—as to just how you prepare it.

Meat Souffle
4 tablespoons butter.
4 tablespoons flour.
1/2 teaspoon salt.
1/4 teaspoon pepper.
2 cups milk.
2 cups chopped meat.
1 teaspoon chopped parsley or green peppers or stuffed olives.

1 teaspoon onion juice.
1 cup soft bread crumbs.
2 egg yolks.

2 egg whites.
Melt butter, mix with flour, salt and pepper, and blend well. Add milk slowly and bring to boiling point, stirring constantly. Season the meat and mix with chopped parsley and onion juice. Add to white sauce with soft bread crumbs and egg yolks. Fold in stiffly beaten egg whites. Turn into a well-oiled baking dish and bake in a moderate oven of 350 degrees F. for 30 minutes. Serve at once.

2 cups meat, diced.

Mix ingredients lightly. Arrange on crisp lettuce. Garnish with additional salad dressing.
