

13-Year-Old Seriously Injured

A 13-year-old Farmington girl suffered serious injuries Dec. 11 when she was struck by a pickup truck while crossing Farmington Road near Orchard Street.

Kathy Theobald, daughter of Mr. and Mrs. Kenneth Theobald of 33988 Moore, was reported to be in critical condition late Thursday and undergoing intensive care at Children's Hospital, Detroit, after

the accident at 8 a.m. Wednesday.

Kathy suffered multiple head and body injuries, city public safety director said.

Driver of the truck was Henry Helm of 13689 Surry, Livonia. Preliminary investigation indicated that Helm was exceeding the 25 miles per hour posted limit and that Kathy was crossing against the Farmington Road-Orchard light.

Heinz was traveling north on Farmington Road and Miss Theobald was crossing west to east.

The truck stopped more than 100 feet north of the intersection and Miss Theobald was thrown 24 feet in front of the truck.

Point of impact was not determined Thursday, officers said.
