may, at the option of the taxpayer, be considered as income and included in gross income for the taxable year in which received. The election once made is binding for all subsequent years unless the Commissioner approves a change to a different method of accounting. Amounts received under the Soil Conservation and Domestic Allotment Act, as amended, the Price Adjustment Act of 1935, section 303 of the Agricultural Adjustment Act, as amended, and the Sugar Act of 1937 constitute taxable income to the recipients for Federal income tax purposes.

To the Editor:

Referring to the letter to the editor, dated January 25, 1943, appearing on page 4, column 5 of the Enterprise on February 11, 1943, and replying to the taxpayer's questions:

Dear Taxpayer:

If you had a fire at this place that you pay taxes on, I feel certain that you would not hesitate one moment to call upon the services of the volunteer firemen. I am also certain that they would not hesitate to assist you in your time of need. They would be to every fire to the last man if it was possible to be on call every hour of the day or night, but that is not possible; each must work where he is most needed during this national emergency. It is impossible to be nearby at all times.

A number of the regulars have gone to defend your right to be a taxpayer and have free speech so we on the home front have to work just that much harder until these men return and resume their places on the truck.

The commission designates a time and place for reviewing any dissatisfied taxpayer. You might appoint yourself as a committee of one and voice your grievance to the proper person.

As to your query "they were paid, weren't they?"—I hope, dear taxpayer, that you are not so near-sighted as to think that the men are volunteers for the sake of the remuneration.

No resident, within sound of the siren, can truthfully say "it isn't my fire, why should I help."

May I suggest to you that you realize that it is impossible for all the firemen to go to all the fires, and if you are able to count the firemen as the truck goes by, put on your hat and count yourself in next time the whistle blows.
