## The facts about the ELECTRIC APPLIANCE SITUATION

People come into our offices—and to department stores, hardware stores and other appliance dealers—with one question uppermost in their minds: "When can I get a new electric iron? Or an electric clock? Or a washer? I understand they're being made again. And I've seen them advertised in the magazines."

Here are the facts about the electric appliance situation. Manufacturers are resuming production of a limited number of appliances. Until they can reconvert their plants to full peacetime operation, the number built during the first few months will be small.

The demand will far exceed the supply. At least at first, what appliances are available will be spread so thin among the various appliance dealers that there will be very few on any one dealer's shelves. The first appliances released by manufacturers will go to department stores, hardware stores, home appliance shops, etc.—dealers whose very existence depends upon the sale of merchandise. The Detroit Edison Company—because it handles appliances only incidentally to its principal business of selling electric service—will be among the last to get them. Our policy has always been "See your dealer first." Until the dealers' shelves are stocked, we shall have very few electric appliances for sale.

Please remember that your dealer's supply will be short. He is anxious to sell you the appliances you want, but he can obtain no more than his limited allotment. We are equally anxious to have electric appliances once more available for all who want them. We hope the time may not be too far off.
