(Continued from Page Two) try, as nearly as I can absorb it from the people who know: Unless economic conditions are restored to normal throughout the world, chaos will engulf Europe, and eventually the clash between communism and democracy as we understand it, will mean war between Russia and the United States. Since it is now believed that Russia will have the atom bomb in from four to ten days (see report of the President's advisory commission on nuclear energy), such a war would mean extermination, if not of the human race, certainly of civilization as we know it.

Granted this is true, the spread of communism in Europe (and elsewhere) must be checked now because: If either France or Italy goes Red, Russia will not co-operate in a Joint peace agreement for Germany and Austria. Without such agreement, Europe cannot be restored to normal. Chaos and communism will follow.

If Russia is stopped in her tracks if we prevent her from moving south into Greece, Turkey and the Middle East, and west of the line she holds at present from her German south through the Balkans to Greece, she will be forced to stop aggression in Europe; forced to co-operate with the western powers for her own preservation. That as I understand it, is what some people call the "Truman Doctrine." It isn't quite fair to give it such an exclusive label when it never could have been put into effect without the yeoman service of men like Vandenberg and the other bipartisan support it has received.

This does not mean that we have "lost faith in democracy" or its ability to compete in a fair field with communism. It means we are going to see that a fair field is maintained; that Russia will not be permitted to create chaos or to draw on the type of force and terror she has used so far (literally in Hungary), to enforce her way of life upon the world.

So, if you are traveling westward from Chicago, and it was in Marshall that the now gigantic and powerful Brotherhood of Locomotive-Engineers was organized. In the old railroad days travelers all over the country ranked themselves as "Marshall vendors" and "Marshall duck" which they had eaten in meal-stops in the town.

Probably the No. 1 historical occurrence in Marshall was the famous Crosswhite case, which truly was the seed which grew into the Civil War.

Marshall had been a center of anti-slavery agitation for many years when, in 1845, one Adam Crosswhite, a slave who had escaped from Kentucky, was seized by force by his former owners who had followed him from the Bluegrass country. Crosswhite had been two years in Marshall and had become established as a peaceful, honest and respectable resident. When the Kentuckians seized him by force, the whole town of Marshall rose in his defense. He was freed from his captors and he and his family were sent into Canada - and the Kentuckians thrown into jail! Two years later suit was filed by the Kentuckians against the residents of Marshall, and a verdict in favor of the Southerners was found in Detroit. The Crosswhite case brought about passage of the so-called Fugitive Slave Law in 1850 - and it was that law which actually brought conflict between states, between brothers. Today a great boulder stands on the spot where Adam Crosswhite lived in Marshall.

MARSHALL

Strange how we pass through a town, time after time, year after year, and yet know nothing about the town except what might be seen along a few blocks of the main street. There's nothing along that street to tell anything of the town's background. No clue as to the happenings in the town in bygone days.

So it is with the placid little town of Marshall, west of Detroit on US 12, a town most Michiganians traverse when heading westward. We know it's an attractive little town, tree-shaded streets, a green circle in its center, with a fountain bubbling, that's about all.

Just a Marshall is an utterly fascinating place if you budget out time for yet a bit of exploration - time to hunt out markers and monuments - time to delve into rich historical background.

Marshall parades a anti-bellum mansion and intriguing architecture, but, more than that, rich history has been written there. For years Marshall was the principal point on the railroad between Detroit and Chicago, and it was in Marshall that the now gigantic and powerful Brotherhood of Locomotive-Engineers was organized.
