A policy of direct appointment of second lieutenants to the National Guard of qualified former enlisted men of all grades has been an-nounced by Major General Kenneth F. Cramer, chief of National Guard

Bureau.

Former enlisted men having a minimum of six months of service in the Army of the United States between December 7, 1941 and June 30, 1947, are now eligible for direct appointment as second lieutenants in the National Guard if they meet the following requirements.
