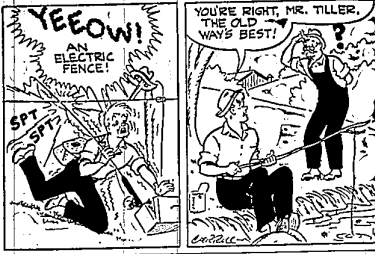


WEEKLY CROSSWORD PUZZLE

REGISTRATION NOTICE FOR GENERAL PRIMARY ELECTION TUESDAY, AUGUST 5, 1952 TO THE QUALIFIED ELECTORS OF THE CITY OF FARMINGTON, COUNTY OF OAKLAND, MICHIGAN:

Notice is hereby given that in conformity with the "Michigan Election Law", I, the undersigned City Clerk, will, upon any day except Sunday and a legal holiday, the day of any regular or special election or primary election, receive for registration the name of any legal voter in said City not already registered, who may apply to me personally for such registration. Provided, however, that I can receive no names for registration during the time intervening between the Thirtieth Day before any regular, special or official primary election, and the day of such election.

Monday, July 7, 1952, Last Day, The Thirtieth Day preceding said Election, Last Day for General Registration by Personal Application for said Election from 8 o'clock a.m. until 8 o'clock p.m. on said day for the purpose of reviewing the registration and registering such of the qualified electors in said City as shall properly apply therefor.

The name of no person but an actual resident of the precinct at the time of said registration, and entitled under the Constitution, if remaining such resident, to vote at the next election, shall be entered in the registration book.

By Miscellaneous Resolution Number 2415, adopted by the Board of Supervisors of Oakland County, it is resolved that in accordance with the provisions of Act No. 5, Public Acts of the first special legislative session of 1948, the registration of electors on primary and election days is discontinued in Oakland County, Michigan, from the effective date of said Act.
