

PHONE COMPANY BIG CONTRIBUTOR TO SCHOOL FUND

Michigan Bell Telephone Company will make a record contribution of \$5,250,000 to the Primary School Fund this year.

A check for \$4,143,000 covering the company's half-year payment has been turned over to Louis M. Nims, state revenue commissioner.

The 1955 payments will exceed the tax of a year ago by more than \$1,000,000. Payments this year, Nims said, will raise the company's total contribution to \$12,800,000 since 1938 when the Primary School Fund provision was embodied in the state constitution.

The company's tax is allocated to school districts throughout the state on the basis of the school census. Michigan Bell is the primary single contributor to the Primary School Fund.
