On Sunday, September 13, the Reverend A. Karl Boehmke, Pastor of the Lutheran Church of the Shepherd King, Middlebelt and Maple, will be feted on the 20th anniversary of his ordination into the Lutheran ministry.

Pastor Boehmke and his wife, the former Miss Lavonne Telle of St. Louis, reside in West Bloomfield Township with their children, Sharon, 18, who will be attending Valparaiso University this fall, Karl, 15, and Anne, 12.

During the Korean conflict, Pastor Boehmke was stationed at Westover Air Force Base in Massachusetts and saw brief overseas duty as temporary chaplain to the Azores. He also served as part-time assistant to the pastor in New Britain, Conn., and pastor for three years at a church in Leominster, Mass.
