Whether or not 500 acres of Farmington Township will be an nexed by the City of Parmington, will be decided at the ballot box, on Tuesday, Nov. 2.

The Oakland County Board of Supervisors, on Monday, August 9, adopted a resolution approving the election. Acting on their authority, on that same day, County Clerk John D. Murphy set the date as Nov. 2. There will actually be two separate votes—one in the City-Jalarge, and one in the affected area of the Township. For annexation to be approved, it will have to carry a majority of the votes in each of these elections.
