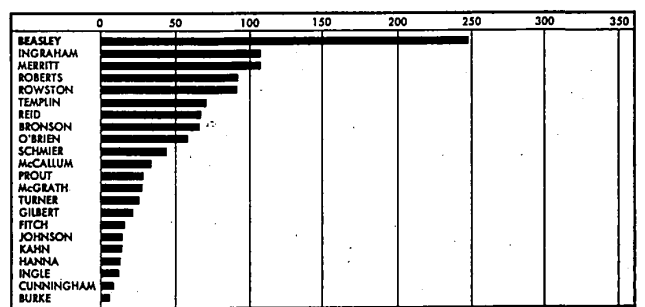

An open report to all Oakland County voters:
