Four mills for Farmington

Farmington school district voters have three choices on the April 29 special elec-tion ballot. We recommend a favorable vote on a four mill tax increase as the best alternative available for the commu-

nity and the school district.

No time in the recent past has been less favorable for a tax increase. In addition, increasing taxes is not necessarily the answer to all the problems facing the Farmington schools.

However, failure to support an adequate school district program may do irreparable harm to the community. The traditional excellence of the Farmington chool district has been eroded by inflation and lack of public confidence.

IF THAT is not corrected, a facet of the Farmington community which has been an important and valuable part of its makeup will decline further. A desirable residential community must have a competitive school system to make it at-tractive to potential home buyers—and make the prices current homeowners paid worthwhile.

There are two millage questions on the ballot next week. The first proposition. for four mills, is a better investment than the second two mill question.

Proposition one will allow small but sig-

nificant improvements in the school district's program, which no longer equals, in variety of classes or depth of study, programs in neighboring districts. The second question means a program the same as this year's.

THE VOTE next week will be the third request for a school tax increase in the past three years. Taxpayer resistance to pleas for higher millage seems to stem principally from disenchantment with the school board and administration. Voters demand quality education for their investment of money and their children's

Quality education includes both a responsive board and a committed administration. However, the board and administration's job is to allow teachers to do the best job possible educating students. It is the teachers and students who are the backbone of the school district.

A tax increase, unwelcome as it is in economic hard times, is needed to keep the Farmington area's deserved reputa tion as a fine residential area.

Needless to say, if the miliage doesn't pass, there won't be new and updated books. And some say even if the two-mili proposal passes, only nominal numbers of new texts could be purchased to replace worn and ragged ones.

BUT LET US peel back the exterior of the clouds and check the silver lining. Positiveness requires there always is one.

School could become a challenge, an op-portunity to pit your knowledge against those instruments of established author-

ity: books. Teachers could make assignments for students to comb thier texts for outdated facts and figures, bestowing awards on those who discovered the great-

Naturally, the students would also have to provide the correct information.

Farmington teachers might even some day be nationally recognized for their ability to make a silk purse out of a sow's ear. With such an educational achievement, who could doubt but that Farmington's fame would be spread far and

American school systems are touted in Europe as ideals toward which to work. To date. Europeans haven't been able to allocate as much money to education as Americans. But if the millage fails, Farmington may be among the vanguard in showing them what wonders may be accomplished with only minimalmaterials.

As I said, the benefits to the students themselves could be tremendous. Students would feel they had constructively contributed to their own education, thereby making the experience an active rather than a passive one...and everyone knows an active role makes more of an impression than passivity.

And even more valuable, students would be taught independence of thought. It would be graphically demonstrated that just because it's printed, it isn't necessarily the truth.

They would be taught to look behind bookish authority, and check printed opinions and facts against what they know or believe to be true. And it won't stop there, for if printed authority is suspect, so is any other kind.

Who knows? If Farmington students had had the opportunity sooner, maybe Watergate and other political scandals would never have happened. At least not because of public gullibility.

So there it is for positiveness. And just remember, if the millage fails, opportunity knocks.

Cut container litter

It's a modification of those old Burma Shave signs you used to see along the road:
Spring is sprang;
Grass is riz;
Where last year's litter laying is.
There's so much of it, now that the snow has gone. Along the street by the house; beside the expressways: around erriances to businesses.
Litter is ugly. It's expensive to clean up. And if you consider the natural resources of paper and metal and glass used in packaging, together with the energy required to manufacture it, throwavay litter is a terrible waste.
Which is why there is presently in the State, Legislature a bill requiring the use of returnable beverage containers.
That isn't to say that all litter is from pop bottless and becruese glass and aluminum do not decompose as paper does, the beverage containers, are a particularly irritating and long-lasting class of litter.

THE ARGUMENTS against the bill are essentially self-serving.

1. Returnable beverage containers would cut jobs now being provided to workers making the endless stream of glass bottles and aluminum cans now being used. Probably that's true. but an Oregon State University study (where they have been on throwaway containers) indicates that any job loss was more than offset by increased jobs in trucking and handling sectors. In addition, a Western Michigan University economist who looked at the problem concluded that the net job effect of a returnable container bill in Michigan would be to increase jobs in Michigan by several thousands.

2. Making returnable beverage containers the

law would do little in reducing litter. False, evidently. The Oregon highway department found after the non-returnable containers were banned highway beverage litter dropped 90 per cent. Other studies indicate litter reductions of the order of 80 per cent, which is little little good. Evidently, the folks in Oregon are sufficiently concerned with saving money that they are willing to take their returnable bottles and cars back to the store for a refund, there is no reason to be lieve that Michigan people are any less thritty.

3. Bamming non-returnable containers would be an aggravation, especially for the retailers who have to put up with time lost at the checkout counter, and the handling charges True. But on balance, is it in the public interest to make our land ugly and waste netural resources and energy in making returnable cars and bottles simply because of aggravation? I think not.

If retailers find their costs increased by such procedures, the solution is to pass them along to the people who buy such products, rather than forcing the people who do not to subsidize those who do via higher energy costs and litter clean-up crews along the roads.
